DESCRIPTION OF REQUEST: (state briefly why legislative action is requested)

The Department of Public Works is requesting the Legislature's approval to enter into an agreement with Callanan Industries, Inc., for our annual hauling and placing contract. The 29.43 miles of County roadways included in the contract are:

CR2 from SR443 to CR1 (Town of Berne) 4.8 miles
CR151 from Terminal Rd. to Airport Park Blvd. (Town of Colonie) 1.4 miles
Hockey Lane from Dead End to Airport Term Rd. (Town of Colonie) 0.14 miles
Old Albany Shaker Road from CR151 to Dead End (Town of Colonie) 0.5 miles
CR160 from CR151 to Dead End (Town of Colonie) 0.6 miles
Heritage Lane from CR 151 to Dead End (Town of Colonie) 0.6 miles
CR154 from CR151 to SR5 (Town of Colonie) 1.98 miles
CR253 from CR261 to SR146 (Town of Guilderland/Knox) 2.4 miles
CR408 from CR1 to CR402 (Town of Westerlo) 5.96 miles
CR352 from CR358 to CR360 (Town of Rensselaerville) 1.05 miles
CR352 from CR357 to CR351 (Town of Rensselaerville) 1.79 miles
CR356 from CR353 to CR352 (Town of Rensselaerville) 4.3 miles
CR354 from CR362 to County Line (Town of Rensselaerville) 1.83 miles
CR362 from County Line to CR354 (Town of Rensselaerville) 2.08

The County Purchasing Agent received six (6) bids for this project. Callanan Industries, Inc. was the low bidder in an amount not to exceed \$4,625,669.79. The Bridge & Road Repair Line D95112.44075 will be used to fund this project through the annual Consolidated Local Street and Highway Improvements Program (CHIPS). The contract is 100% State funded.
