The Bender Melon Farm Preserve, which is owned by the Mohawk Hudson Land Conservancy (MHLC), is divided into two parcels by the Albany County Rail Trail. Connecting the two parcels is the steel bridge that was built directly above and traverses the Rail Trail. With the approval of this quitclaim deed and easement, any ambiguities regarding the ownership of the bridge itself would be settled, with MHLC formally accepting ownership and responsibility for the structure, and indemnifying Albany County.
