Justification: (state briefly why legislative action is requested)

In response to requests made by the District Attorney and the District Attorneys Association of the State of New York (DAASNY), the state has increased the Albany County District Attorney's annual Aid to Prosecution award from \$176,540 to \$943,253. These additional funds will be used to attract and retain experienced prosecutors and personnel to assist in our prosecution efforts. We will not receive a DCJS grant contract for this funding; rather, money will be automatically disbursed to the county in one payment. This funding assistance is being provided to help offset the dramatic increase in the costs associated with prosecutorial services as a result of criminal justice reforms for the period of April 1, 2023 to March 31, 2024. According to the terms of the award, the county shall promptly make this funding available to the respective district attorney's office. Award letter is attached.

This grant was increased by \$766,713 to \$943,253 in order to fund our office closer to levels we had requested last year. The first \$176,540 of the ATP grant continues to be used to partially fund the salaries of the Chief Assistant and Major Offense Bureau Chiefs, spread over two years, as in years past. We are asking that 75% of the additional \$766,713 (\$575,035) be used to fund a new enhanced pay line (19954X). This money will be used to attract retain qualified personnel for the office. The remaining 25% of the additional funds would be used to fund the same line in next year's budget from 1/1/2024 through 3/31/2023.
