Dear Chairman Joyce:

The attached correspondence is forwarded for presentation to the Albany County Legislature.

Legislative approval is required to amend a service and purchase agreement between the Albany County Sheriff's Office and Axon Enterprise, Inc. of Scottsdale, AZ authorized by Resolution No. 46 of 2023. This amendment would authorize the acquisition of Model 10 Taser devices and accessory equipment in place of the Model 7 devices previously authorized in the aforementioned resolution and yet to be received. The newer Model 10 became available shortly after the date of the original request and will afford improved performance, capabilities, and longevity. This amendment would also authorize and accept the new quote (Q-491579-45145.753BD) associated with the change from the originally authorized Taser Model 7 to the newly requested Model 10.

The amended 5-year service agreement would begin August 1, 2023 and extend through December 31, 2027 for a total cost 3,080,145.66. However, the total increase from the original agreement is \$13,932.41 over the course of the agreement. Payment will still be made from seizure funds supplemented by grant and budgeted funds as needed. The funds will be allocated as follows:
