## PROPOSAL SECTION II: Description of the Problem

## 2.1 - Describe the specific problem this project will be addressing and its impact on the community and individuals you serve.

The problem is the lack of recreational recovery space for Albany County residents.

The impact this is having on the community and individuals we serve is without a sober space people in recovery only have meetings or other limited venues to find sober supports.

## 2.2 – When applicable, include data/statistics that describe the target population and the effect of the opioid epidemic.

The target population is the nearly 1500 individuals in Albany County that are receiving treatment for an opioid use disorder, as well as those battling other addictions, that lack a safe place to build a support network. A study published by the National Institute of Health, "Alone on the Inside: The Impact of Social Isolation and Helping Others on AOD Use and Criminal Activity", found increased risk of relapse, incarceration, and violent crime associated with social isolation whereas getting active in service during treatment decreased the likelihood of these outcomes in the year post-treatment.

### 2.3 – Describe any previous efforts to address this problem and the reasons they were or were not successful.

There have not been any previous efforts to address this problem in Albany County. However, the benefits of providing people in recovery with a place to call their own are being seen throughout the country, including other counties in upstate New York; Monroe County (ROCovery Fitness) and Livingston County (Adventures in Recovery). Pioneered by The Phoenix in 2006, the sober active community model works because it places the emphasis on connection and community.

## PROPOSAL SECTION III: Description of the Approach

## 3.1 – How do you propose to address this problem? Please describe in detail the initiative you will be implementing with this funding.

Hive of Hope proposes to provide a state-of-the-art recreational recovery space for those battling addiction in Albany County, known as The Hive. With this funding, Hive of Hope will staff and equip The Hive with the resources needed to implement and expand a vast array of healthy activities and opportunities for connection at The Hive.

In addition to being open to the public 5 days a week, including Saturdays, The Hive will offer service opportunities, exercise classes, music lessons, hikes, dances, holiday celebrations, movie nights, concerts, support groups, workshops for peers, barbecues, and so much more. Additionally, Hive of Hope will spread public awareness and safety through outreach initiatives and distribution of lifesaving naloxone and testing strips.

Hive of Hope's motto "Sober Living Through Giving" is an expression of our belief that service is the key to sobriety as it builds self-esteem, reduces stigma, and eliminates the guilt and shame that often accompanies substance use. With this funding Hive of Hope will have the personnel to plan and implement opportunities for those in recovery to give back. Events will include connecting with United Way for their 518 Day of Service, preparing holiday meals at the local city missions, distributing naloxone and sandwiches to the community, leading programs and assisting with operations at the Hive, and much more.

## 3.2 – How does this initiative relate to the priorities established by the New York State Opioid Settlement Task Force and by Albany County?

Hive of Hope's initiative focuses on recovery but reaches across the service continuum into prevention and treatment. Our location in the inner-city makes us easily accessible for an underserved priority population which addresses service disparity and transportation barriers. Our proximity to a methadone clinic makes us a convenient stop for those practicing harm reduction in Albany County, who may also benefit from our distribution of life saving naloxone and testing strips.

Hive of Hope's focus on service, exercise, recreation, and nutrition is an innovative approach that expands access to integrated behavioral health services and addresses challenges related to the social determinants of heath.

Hive of Hope's attendance at community events, outreach and service initiatives, partnership with local organizations and drug treatment court, and presence on main street, increase prevention and community education efforts.

## 3.3 – Is there an evidence based or promising practice or service model that will be implemented? If so, please describe how staff will be trained, and how fidelity to the model will be monitored.

Hive of Hope will be implementing the sober active community model that is showing incredible promise and quickly spreading throughout the country. The model's focus on community is achieved through sober social networks, meaningful activities, and restorative culture. Staff will be trained to follow the guidance of Hive of Hope's "Community Standard", that promotes a safe, inclusive, and supportive environment. Fidelity to the model will be monitored by surveying our members and tracking event participation and impact.

### 3.4 – How will the project be staffed?

The project will be staffed by two full-time Certified Recovery Peer Advocates and several volunteers with lived experience battling addiction.

#### 3.5 – What grant-funded and in-kind resources will be devoted to this project?

Hive of Hope will be devoting all the amenities within our recovery recreation space including game tables, exercise equipment, electronics, furniture, and more to ensuring the success of this project.

### PROPOSAL SECTION IV: Experience and Expertise

## 4.1 – Please describe the proposing agency/organization, including its location, years in business, philosophy and role in combating Albany County's opioid epidemic.

Hive of Hope is a sober active community with a recovery recreation center in the City of Albany. Hive of Hope has been in business for two years and has been operating their recovery recreation center for one year. Our philosophy is that living with addiction is a lonely and isolating condition, and for people who are attempting the long and difficult journey of recovery, they need non-judgmental and unconditional love and support from a devoted community to stand a chance. Hive of Hope serves as the central headquarters for people in recovery to combat Albany County's opioid epidemic.

#### 4.2 – Discuss the proposing agency's experience with the target population for this project.

Hive of Hope has been serving the target population for two years. During that time their recovery community has grown to over 450 members and they have hosted nearly 100 events and activities for the target population. The Hive recognizes that this type of recreational center is a new model in Albany County, but we believe that an unprecedented opioid epidemic requires innovative solutions and that the Hive is uniquely positioned to address issues related to stable recovery.

## 4.3 – Provide brief bios for the staff members who will be implementing this project or job descriptions if this will require new hires.

This project will be implemented by Hive of Hope's Founder & Director, Nathan Writer with the assistance of the Hive's Operations Manager, Shawn Sanders.

Nathan is a lifelong resident of Albany County and graduate of the University at Albany and Albany Law School. He has been in recovery for over three years and was inspired to create Hive of Hope when his battles in early recovery with boredom, isolation and depression, demonstrated a need for a recovery recreation space. He founded Hive of Hope in 2021 and shortly after became a Certified Recovery Peer Advocate and Certified Personal Trainer.

Shawn Sanders is the first-born son of a single mother. He was raised in poverty in Westchester County and began battling addiction in his teens. In 2016, Shawn began his recovery journey, which eventually led him Hospitality House in 2022. His lived experience, coupled with his genuine desire to help people overcome the disease of addiction led him to a position with Hive of Hope in 2023 as their Operations Manager. Shortly thereafter, Shawn's pursuit of a career in addiction was furthered by his acceptance of a part-time position with Hospitality House. Certification as a CRPA is the next steppingstone in Shawn's journey and his ability to connect and adapt in any environment will make him the ideal candidate for outreach and prevention.

## 4.4 – Describe the community partnerships that will assist the proposing agency in implementing this project.

Hive of Hope's partnership with Hospitality House, Addiction Care Center of Albany, and Hope House has exposed hundreds of people to the benefits of the Hive's recovery recreation center and is proving to be an incredible tool for seamless reintegration and long-term recovery support.

Hive of Hope's connection with recovery organizations locally, such as Capital District Recovery Center and Healing Springs, as well as those statewide including ROCovery Fitness, Adventures in Recovery, Sober Active Recovery Adirondacks, and Devin's Rec Room unites the recovery community.

Hive of Hope also serves as a resource hub for our members and others in our neighborhood thanks to our connections with local community and government organizations like Healthy Capital District, MVP, United Way, the SEAT Center, Connect Center, Trinity Alliance, Schenectady Mission, Capital District Latinos, and Albany County Drug Court

Hive of Hope is seeking to expand their opioid use disorder outreach, prevention, treatment, and recovery by funding, at a rate of 60%, a Director/CRPA/NASM-CPT Recovery & Recreation Specialist position at \$59,400 and by funding, at a rate of 100%, an Operations Manager/CRPA Outreach & Prevention Specialist position at \$37,500/year. Grant funds will be used to staff the recovery recreation center, as well as provide them with outreach supplies and equipment, and support their travel to in-community events.

Hive of Hope will provide in-kind support in the form of recovery recreation space, exercise and recreation equipment, office equipment, vast referral network, and supervision.

Our programs successful implementation will be evaluated by a systematic approach which analyzes both empirical and non-empirical date. Specific short-term goals include an enhanced sense of connection, hope, and belonging. Intermediate goals include maintained sobriety and improved mental and physical health. ## ATTACHMENT "A" NON-COLLUSIVE BIDDING CERTIFICATE PURSUANT TO SECTION 103-D OF THE NEW YORK STATE GENERAL MUNICIPAL LAW

- A. By submission of this bid, each bidder and each person signing on behalf of any bidder certifies, and in the case of a joint bid, each party thereto certifies as to its own organizations, under penalty of perjury, that to the best of knowledge and belief:
- (1) The prices in this bid have been arrived at independently without collusion, consultation, communication, or agreement, for the purpose of restricting competition, as to any matter relating to such prices with any other bidder or with any competitor.
- (2) Unless otherwise required by law, the prices which have been quoted in this bid have not knowingly been disclosed by the bidder and will not knowingly be disclosed by the bidder, directly or indirectly, prior to opening, to any bidder or to any competitor.
- (3) No attempt has been made or will be made by the bidder to induce any other person, partnership or corporation to submit or not to submit a bid for the purpose of restricting competition.

A bid shall not be considered for award nor shall any award be made where (1), (2), and (3) above have not been complied with; provided, however, that in any case the bidder cannot make the foregoing certification, the bidder shall so state and shall furnish with the bid a signed statement which sets forth in detail the reasons thereof. Where (1), (2), and (3) above have not been complied with, the bid shall not be considered for any award nor shall any award be made unless the head of the Purchasing Unit to the political subdivision, public department, agency or official thereof to which the bid is made, or his designee, determines that such disclosure was not made for the purpose of restricting competition.

The fact that a bidder (a) has published price lists, rates, or tariffs covering items being procured, (b) has informed prospective customer of proposed or pending publication of new or revised price lists for such items, or (c) has sold the same items to other customers at the same prices being bid, does not constitute, without more, a disclosure within the meaning of paragraph "A" above.

B. FOR-NY is dedicated to breaking down the barriers created by negative public perception that result in discrimination and policies that block or interfere with accessing recovery support services: access to addiction treatment, healthcare, housing, education and employment.

FOR-NY is working to build infrastructure around the state through local Recovery Community Organizations (RCOs) and Recovery Community Outreach Centers (RCOCs) that build support for people living in recovery and others in need.

Hive of Hope is an exemplary recovery community outreach center. Only open a year, and without permanent and sustainable funding-they have built a state-of-the-art community center serving over 400 individuals, with an additional 3,500 visits. It is a safe haven for those in recovery to meet like-minded individuals while building connections, providing employment, and providing volunteer opportunities. Last year members at Hive of Hope completed 1000 hours of community service preparing holiday meals for the Capital City Rescue Mission alone.

Nathan Writer, the founder of the Hive of Hope is a leader in his community and a role model for the individuals he serves. Nate has consistently shown himself to be a dependable ally for not just FOR-NY, but for the recovery community as a whole. He exudes professionalism, and has partnered with FOR-NY to:

- Lead a spring clean-up at the Boys and Girls Club of Albany
- Facilitate our *Reimagining Recovery Series* engaging the community about substance use and recovery.
- Assist with organizing and volunteering for FOR-NY events (Annual Recovery Conference and Stand Up For Recovery Day, our annual day of advocacy).
- Despite only being open a year, planned and partnered with ROCovery Fitness and other recovery organizations to organize Sober Fest 2023, a three-day event bringing recovery advocates together throughout the state, a major undertaking for any organization.
- Organized monthly hikes throughout the state with other recovery advocates.

Located in Arbor Hill, this center offers a critical refuge in an area of Albany that is currently underserved. The inventory of abandoned buildings, and issues with the community feeling unsafe continue to receive regular media coverage. Hive of Hope counters that narrative and offers prosocial activities to keep our community's youth engaged, and working toward a positive future.

With additional funding Hive of Hope will be able to continue as a constitutive resource of the Recovery Community. FOR-NY would be grateful for any assistance you could offer them.

Dear Donors,

I have been sober for 3 years and 7 months. In this time, I have started and completed my Master of Psychology and begun working on my Master of Clinical Social Work. I have become a certified peer advocate, a fully credentialed substance abuse counselor, have worked in the substance abuse field for two-and-one-half years and carry a full case load in my position at Hospitality House. I have married and gained a level of personal stability that was previously unthinkable. Before this change in my life, I served time in prison, was unable to hold a full-time job for longer than a month or two, and was largely homeless.

The reason I am beginning this letter on the Hive of Hope's behalf with my own story is to highlight a critical piece of support I needed but did not have while I tried for fifteen years to pull my life together. This was a space to exist, process, and socialize in early recovery. The Hive of Hope provides this to people and had these services been available to me prior I believe I would have gained the traction I needed to achieve recovery years earlier than I did. Currently, for those in early recovery existence can often be wandering the city in search of a bathroom or needlessly loitering in the public library. Spaces for people in recovery to socialize, exercise, relax, and be wanted were sorely missing in Albany before the establishment of the Hive of Hope. It has benefited both the community and those in recovery by providing a destination for individuals trying to improve themselves.

The Hive of Hope continues to support me as I move into sustained recovery. I use the place as a spot to stop in and recommit to my program. I often use the safe, quite place to write papers for school. When time permits, I wander into the gym to work out to maintain my health. I recharge spiritually at the Hive when I stop in for breakfast on Saturday or go on their organized hikes. I regularly attend meetings at the Hive or other evening events. Additionally, the Hive gives me a place to give back to and do service. The coinvent location is in an area of Albany that remains underserved and sorely lacks venues for safe and sober recreation. I cannot credit the Hive enough for aiding my recovery and thank you for your continued support of its mission.
