We have reviewed the information with respect to the administration of an On-the-Job Training Grant Program by the Capital Region Workforce Development Board. From an eligibility perspective, household/individuals that experienced unemployment or underemployment is deemed to be an eligible use. The expenditure category 2.10, "Assistance to Households – Assistance to Unemployed or Underemployed Workers," appears to the most appropriate. The County should ensure both the decision process and the ultimate number of unemployed/underemployed individuals served is clearly documented. For individuals served, at a minimum, the following should be documented: 1. number of workers enrolled in sectoral job training programs, 2. number of workers completing sectoral job training programs, and 3. if applicable, number of people participating in summer youth employment programs. As always, on a forward moving basis, the County should continue to monitor the program administrator to ensure they have adequate procedures in place relating to internal controls and record keeping.
