WHEREAS, The Commissioner of Health has requested authorization to enter into an agreement with the New York State Governor's Traffic Safety Committee regarding the Highway Safety Grant Program in an amount of \$35,000 for the term commencing October 1, 2024 and ending September 30, 2025, and

WHEREAS, The Commissioner has indicated that the funding will be used to distribute pedestrian safety information at select intersections that are at risk for accidents, provide safety information in schools, and conduct community outreach regarding pedestrian safety, and

WHEREAS, The Commissioner has also indicated a budget amendment is necessary to incorporate a portion of the grant funding into the 2024 Department of Health Budget, now, therefore, be it

RESOLVED, By the Albany County Legislature that the County Executive is authorized to enter into an agreement with the New York State Governor's Traffic Safety Committee regarding the Highway Safety Grant Program in an amount of \$35,000 for the term commencing October 1, 2024 and ending September 30, 2025, and, be it further
