Re: New York State Enough is Enough Program Letter of Invitation - **Response Required**

Dear Colleague:

The New York State Office for the Prevention of Domestic Violence (OPDV) administers the New York State Enough is Enough program. This letter is to inform you of your eligibility for the Enough is Enough program, pending approval by the Office of the State Comptroller. As a New York State Department of Health (NYSDOH) approved Rape Crisis Program, NYSDOH-funded Rape Prevention Education Program Regional Center for Sexual Assault Prevention, or historically funded Enough is Enough program, your agency is eligible for this funding.

This program will fund providers for a three-year period from 5/1/2022 – 4/30/2025, contingent on continued availability of funding. This funding will allow funded programs to support colleges and universities in implementation of the requirements of the Enough is Enough law, including prevention education and direct victim services on campuses. Programs are expected to establish, maintain, and regularly review Memoranda of Understanding (MOUs) or partnership agreements with local colleges and universities and to deliver training, prevention education, victim services, and other activities based on the needs of each campus population.

The attached work plan outlines the requirements of the Enough is Enough program for the new funding cycle.

Funding will be distributed to each eligible contractor on the basis of the counties served by the program, as reported to the New York State Department of Health, and the number of students enrolled in colleges and universities located in each county in New York State, as reported in the State Education Department (SED) Office of Research and Information Systems (ORIS) Information Reporting Systems (IRS). In counties served by multiple Enough is Enough contractors the total number of students enrolled in all colleges and universities located in those counties will be equally distributed among the programs serving the county. Funding is also provided to programs in counties without colleges and universities to support the ancillary demand for services as a result of the Enough is Enough law. If all eligible programs accept the invitation to participate, it is anticipated that your three-year award will be approximately \$135856 per year. In the event some

programs reject the funding, total awards will increase accordingly with the funding available.

To participate in the Enough is Enough Program, please fill out the form at this [link](#) indicating acceptance of the funds **by March 1, 2022**. By indicating your acceptance on the form, you are agreeing to the following:

- Your organization will accept the award for the amount determined by the available funding and the total number of participating eligible providers;
- Your organization will use the funds for services consistent with the attached workplan;
- Your organization will submit quarterly reports identifying services provided and costs incurred by the program in the format designated by the New York State Office for the Prevention of Domestic Violence.

If you do not wish to participate in the Enough is Enough program, please fill out the form at this [link](#) declining the funding by the same date, March 1, 2022, so that the funding can be reallocated.
