Albany County Department of Health is requesting approval to create a Public Health Preparedness Coordinator positon. This position will be in our Emergency Preparedness division that focuses on strengthening the capacity to respond to all types of hazards including infectious disease outbreaks, natural disasters, biological, chemical and radiological incidents, and explosions. The duties of this position involve overseeing logistics planning and operations, maintains program inventory and supplies, and completes annual and quarterly reports related to public health emergency preparedness grants and performance management. This position will be funded partially from our emergency preparedness grant and state aid reimbursement.
