<u>Justification</u>: (state briefly why legislative action is requested)

The Department of Mental Health requests permission to enter into a contract in 2023 with Trinity Alliance for the provision of intensive residential services to Albany County citizens with substance abuse and narcotic addiction related issues. NYS Office of Addiction Services and Supports (OASAS) shall provide pass through funding to Trinity Alliance through Albany County Department of Mental Health in the amount of \$423,628. This appropriation is anticipated in the 2023 budget. There is no County share associated with this contract.
