## <u>Justification</u>: (state briefly why legislative action is requested)

The Department of General Services requests authorization for contract with DLC Electric, LLC as the Electrical Work Contractor (EWC) for the Capital District Youth Center, Inc. (CDYCI) Construction Project further described in RFB # 2022-124. The scope of work will also include Alternates #1 and #3 noted in RFB # 2022-124.

The cost of these services is \$3,435,000 with a 10 % contingency of \$343,500, plus \$279,100 for Alternate #1 and \$50,600 for Alternate #3, for a not to exceed total of \$4,108,200.00.

Funding for these services will be split between the State at 89% and participating Local County's at 11%.

Albany County's cost for these services will be covered under bond number HHWO pursuant to Res. No. 570 of 2018 adopted December 3, 2018.

The term of this contract will commence upon signing and continue until the project is completed and signed off by the Department of General Services. The projected term will be January 1, 2023 through December 31, 2025.
