This request is to allow Albany County CVSVC to accept funding from the NYS DCJS to support Rape Crisis Services and Prevention Programming. The Albany County Crime Victim and Sexual Violence Center Project will provide direct services to sexual assault victims, including confidential therapy to sexual assault victims and those affected by the sexual assault, criminal justice advocacy in local courts, 24 hour sexual assault hotline services as well as sexual assault prevention activities for students in local elementary, middle and high schools. This award will provide funding from October 1, 2021 through September 30, 2022.
