The Albany County Department of Health (ACDOH) requests a grant acceptance, contract authorization, and budget amendment for the Tuberculosis Testing for Asylum Seekers grant. This is a non-competitive grant contract of \$500,000 to support tuberculosis testing, clinical services, and related expenditures for the asylum-seeking population. The grant period will be April 1, 2023 through March 31, 2024 and a portion of the grant will be included in ACDOH's 2024 Proposed Budget.
