Properties are withdrawn from tax foreclosure as there exists a significant risk that the County of Albany might be exposed to a liability substantially in excess of the amount that could be recovered by foreclosing the tax lien. Pursuant to ABL resolution No 29 of 2019 the Albany County Disposition Plan, properties "withdrawn" from a foreclosure proceeding can be offered for sale through a sealed bid process with the sale price criteria being "an amount which reflects the benefit to the community stemming from the proposed use of the property. In this regard the Department of Management and Budget through the county website offered properties online through a sealed bid process which was conducted from September 14th until October 14th, 2022.

Authorization is requested to convey property located in the City of Albany, 239 Third Street Tax Map No. 65.56-5-30 to Kingdom Services Global Outreach Ministries, 233 Third Street, Albany NY, 12206 for \$300.00. Kingdom Services Global Outreach Ministries was the sole bidder on this property and their submission indicates a detailed plan to rehabilitate this tax delinquent property which intern will benefit the community.
