Enclosed please find the Albany County Sheriff's Office Request for Legislative Action relative to the above captioned.

Briefly, this request is to enter into an agreement with a qualified vendor to resurface parking lots at the Correctional Facility. The Albany County Purchasing Department in conjunction with Correctional Facility staff developed and distributed an RFB #2021-053 and as a result nine vendors responded. After careful review and consideration, Peter Luizzi & Bros Contracting, Inc. is being recommended as the lowest vendor to submit a bid. The forty plus (40+) year old parking lots are beyond seal cost repair and will need to be replaced. The total cost of this project is \$104,950.00 and will be funded by the 2021 operating budget
