### Describe the arts/cultural/tourism activities your organization provides in Albany County.

Dutch Apple Cruises provides sightseeing tours, private cruises, tour guide services and tour planning services for the City of Albany. We have been ranked the #1 tour in Albany for the past 12 years on TripAdvisor. We provide tourists and locals information about the area and it's rich history. We are a locally owned and operated business that has served the Albany area since 1986.

The Hudson Riverfront is a major part of the City of Albany. It is an underutilized area, despite pedestrians constantly looking to take a boat ride, tour the Slater, bike/walk the path, or to just sit by the river, use a restroom, relax and enjoy views. Tourists and locals alike, are looking for a nice, clean, and safe way to access Albany's riverfront. Our requests for funding will help give pedestrians more access to our riverfront, which is in high demand.

### If an award is made, describe how the funds will help you to sustain your operations in Albany County.

Dutch Apple Cruises is in need of two full transmission repairs. These repairs are necessary for the vessel to run efficiently and use less fuel. We are also in need of repairs in the keel and hull of the boat to prevent any future leakage. The repairs will allow us to continue our current sightseeing and tourism schedule and expend into more service offerings. The repairs of the dock area will improve the safety of operations and also allow us to offer dock space for customers to have riverfront access for the personal watercraft. The new watercraft will expand our offerings and give our city a new way to connect to other local riverfront areas.

Describe the extent to which the COVID-19 pandemic increased or decreased demand for your services. As an option, you may attach to this application any optional information that supports you're the service increase or decrease being described below.

COVID19 had a serious impact on our seasonal, small business. We were ineligible to receive funding for the Restaurant Revitalization or the Shuttered Venue acts, due to being a passenger vessel. We survived the COVID19 pandemic by hard work, dedication and the ability to adapt. Receiving these funds will ensure that we are able to give visitors and locals a beautiful place to view and learn about the riverfront. Dutch Apple Cruises, is the only for profit, waterfront business that has survived in Albany. The Albany Aquaducts and Riverfront Barge, have come and gone. Anthony and Melissa are dedicated small business owners, that will continue to reinvest and give back to the Albany community. The new Skyway has increased foot traffic to our location and helped with the revitalization of our riverfront. We need to continue with these improvements to showcase Albany and it's Hudson River heritage.

# Please provide a short summary of your proposed project including a project name, general description, total cost, reason(s) why you are pursuing the project and anticipated impact:

Finish the updating of our riverfront area. There were not enough funds to replace and repair the perimeter with new fence. We have had multiple incidents each month with break ins - specifically where they are entering through broken fencing areas.

Estimated Cost \$18,000.00

Replace/repair old docks to ensure pedestrian safety and provide small watercraft docking facilities. Our docks are in desperate need of repairs. We have had to turn away a visiting vessels, sail boats, and floating museums, due to inadequate/unsafe dock areas for them to utilize.

Estimated Cost \$20,000.00

Repair both engines and transmissions to ensure the longevity of our vessel and to make them fuel efficient.

Estimated Cost \$20,0000.00

Repairs keel/hull of wood vessel by local boat builder Scarano. Due for overhaul to ensure longevity of the bottom of the vessel to prevent leaks.

Estimated Cost \$40,000.00

Purchase of smaller watercraft (probably pontoon style) to offer more cruises to smaller groups. Possible shuttle to nearby cities (Troy, Cohoes, Coxackie, Hudson) to connect visitors and tourists to the capitol region by waterway. Estimated Cost \$50,000.00

# Please describe the entity's capabilities to implement the project you propose including organizational structure, staff members involved, a summary of similar initiatives you have undertaken and the date they were completed:

We have already been in contact with the fence company and they are ready to start work whenever we can. Dutch Apple Cruises staff members are capable of repairing the dock decking themselves to save costs. We will be paying for the staff hours ourselves, we are just requesting the cost for materials. Our staff have built these docks themselves from scratch 10 years ago and are proficient knowledge in how to do the repairs themselves in order to save costs.

The repairs of the engines and transmissions will be done over the winter, by one of the few companies in the area that specializes in engine repairs and re-hauls. The closest company is located in New Hampshire and requires transport, in addition to the repairs.

Repairs of the keel/hull will be done over the winter also, by local Albany business, Scarano boat builders. These repairs are necessary to prevent leaks and ensure passenger and crew safety. Scarano is the original maker of our vessel.

The new smaller watercraft will be purchased in the spring of 2024. We hope this new venture will create new partnerships with other cities along the riverfront, in addition to an expansion of our services offered. We also anticipate this endeavor creating at least one, possibly two more employees to our crew.

# Please describe, in detail, the impact your proposed project will have on Arts, Culture and/or Tourism in Albany County. Describe how your project will attract new visitors to Albany County. Where possible use metrics/estimates of impact (i.e. increased visitation etc.).

The continuation of the upgrading of our boarding area and vessel will help our business continue to serve the thousands of tourists that visit steamboat square each year. The offering of a new vessel, with possible ferries to other local riverfront areas, will help connect our capital district.

We anticipate to increase visitors by 2,500 passengers in 2024, with an additional increase to 5,000 more passengers (after marketing efforts and word of mouth) in 2025.

Gross cruise ticket sales are expected to increase by \$50,000 is 2024 and \$100,000 by 2025.
