Playhouse Stage Company augments the quality of life for a diverse audience in the Capital Region by producing free summer theatre in an outdoor setting, producing and presenting performing arts events at the historic Cohoes Music Hall, and providing world-class arts education programs to young people in the community through Playhouse Stage Academy. By providing free and affordable admission at our productions, we make theatre an all-inclusive art form, accessible to people from all walks of life and socio-economic backgrounds. Our education programs teach valuable life lessons about collaboration and communication, while helping to train the area's next generation of theatre artists, and setting students up for success across diverse academic pursuits and industries. Playhouse Stage Company takes a leadership role in enhancing the cultural landscape of New York's Capital Region, and is a catalyst for economic and community development in our area.

The Playhouse participated in the Payroll Protection Program, with a round one loan of \$126,937, and a round two loan of \$232,115. Both loans were used exclusively for payroll costs in 2020 and 2021, and were forgiven in their entirety. The Playhouse also drew \$450,000 in Economic Injury Disaster Loans, which must be repaid. Finally, The Playhouse received Shuttered Venue Operator's Grants in the amount of \$143,286.77.

Did your organization lose revenue as a result of the COVID-19 Pandemic? If yes, provide the amount of lost revenue (2020-2022)

The Playhouse, like most organizations, and, indeed, all performing arts institutions nationwide, was impacted dramatically by the COVID-19 pandemic. Negative impacts were felt through both the shutdown of performing arts venues from March of 2020 until April of 2021, as well as the challenging reopening period through the end of 2022. In 2020 alone, \$225,500 in budgeted revenue for ticket sales was lost, despite expenditures already being executed for cancelled productions. In 2021 and 2022, cancellations of events led to additional revenue loses of more than an additional \$100,000. Moreover, audience attendance did not return to form during this period. It is difficult to identify exact amounts of potential revenue lost based on audience attendance habits not returning to normal levels in 2021 and 2022. However, compared to the year immediately prior to the pandemic, ticket sales were reduced in 2021 and 2022, with a total shortall of more than \$180,000 across the two years versus the year pre-pandemic. It is important to note, of course, that, during this period of reduced revenue, pandemic-era guidelines for safety in places of public assembly also created significant new expenses to operate, furthering the pandemic burden. Additionally, with many organizations and individuals choosing, understandably, to direct their discretionary charitable giving to health and human services causes, fundraising for the arts was extraordinarily challenging throughout this period. Compared to the fiscal year immediately pre-pandemic, the Playhouse had fundraising shortfalls in 2020, 2021, and 2022. All told, conservatively, at least three quarters of a million dollars in revenue were lost during these years during and following the pandemic.

Is this a new project or expansion of an existing initiative, please describe.

This request represents an expansion of our long-running youth programs, many of which were either cancelled or relegated to virtual participation during the pandemic. The program detailed herein represents an expansion that doubles our theatrical class offerings, adds an additional youth theatre camp for students ages 5-10, adds two additional school-year based youth productions, and a scholastic field-trip production to be presented at Cohoes Music Hall over the course of an entire month each year.

When the Playhouse youth program began in 1995, it was a small program to add a children's production to the summer season of Park Playhouse, which was a well-known professional theatre company in the county. Since then, the program has expanded to multiple productions that take place throughout the year, and are offered for several age groups in our youth program. In order to help students learn their craft further, classes in movement, vocal, acting, and performance techniques are offered each semester as well. The Scholastic Theatre program offers students the opportunity to see professional theatre that presents curriculum-based productions to help augment the classroom experience. Each of these programs has grown drastically since the programs inception, and the need for an outside organization like Playhouse Stage Company to provide these opportunities for local youths has increased exponentially since the COVID-19 pandemic began in 2020.

To be sure, ARPA funds would be a tremendous boon in helping us achieve the continued expansion of our youth programming over the coming years.

Please provide an executive summary of the proposed program or project for which you are requesting funds. Include a description of the target population, as well as the goals and objectives of your proposed project (500 words or less).

Playhouse Stage Company is seeking program support from Albany County's American Rescue Plan Act grant program to expand both our school-year and summer-based youth theatre arts programs. Long a mainstay of Playhouse programming, these youth activities were initially ceased or relegated to virtual operation during the pandemic shutdown. As our community continues to emerge from this challenging period of time, the Playhouse is working hard to meet the need for enriching, affordable youth programming after school and in the summer months. Compared to the year immediately prior to the pandemic shutdown, the Playhouse, this year, will offer twice as many after-school classes, an additional session of our summer camps for youth, and two additional year-round educational productions with opportunities for student performers to hone their skills. Additionally, the Playhouse wll now offers scholastic field trip opportunities for an entire month at Cohoes Music Hall, offering thousands of elementary-aged students the opportunity to see live theatre as part of their school experience. Across all of our youth arts education programs and productions, students are requesting more tuition assistance than ever, with an increase of 50% of tuition assistance requests in 2022/2023 as compared with pre-pandemic levels. ARPA support through Albany County will allow for our expansion of these vitally important youth enrichment programs despite our pandemic financial losses and despite family assistance needs.

Please explain why this program or project is needed within the County.

Students throughout the region continue to see a decreased funding for and availability of extracurricular and summer-based youth activities in the wake of the pandemic. Studies through national leaders like Americans for the Arts continue to show a considerable impact of the arts for young people's literacy and academic performance, innovation, collaborative skills, confidence and mental well-being. Not only is the Playhouse youth program among the most robust and well-rounded opportunities in the region, but it serves a broad spectrum of Capital Region youths. Since the youth program began in 1995, no student has ever been turned away because of an inability to pay. Playhouse Stage Company continues to fill a need in classes, youth performances, and scholastic theatre programming for youth audiences, and plans to continue this trajectory of growth the meet the rapidly increasing demand for these programs.

The arts help to connect individuals and communities as a societal level by building compassion and promoting

good health. Playhouse youth programs encourage physical well being through dance and movement, while promoting knowledge and building compassion through characters and stories. Due to the crippling and ongoing economic impact of the pandemic, we are seeing a greater number of financial aid requests than ever before for students registering for classes and productions, and Playhouse will continue to meet these demands as much as possible to provide much-needed opportunities for local youths, regardless of their financial position at home or in their schools. On a similar note, the productions put on by our local youths stimulate the local economy with additional hotel stays, parking fees, restaurant patronage and shopping surrounding youth productions. The calendar of youth events has a direct impact on local businesses and drives tourism dollars throughout the Capital Region.

An award made to Playhouse Stage Company will have a regional benefit to the county that is both quantitative and qualitative. The arts are undoubtedly an economy driver for local businesses with the average theatregoer spending \$31.47 above and beyond the cost of their ticket for meals, lodging, and shopping when attending a performance. In addition, the support generated through Playhouse's well-rounded youth programming alleviates additional burden for students who seek extracurricular activities. Scholarships and tuition assistance eliminate barriers and financial burdens to allow students to receive the best possible training without exception. These students will then go on to be well-rounded citizens who are articulate, collaborative thinkers and innovators, which will serve them well into the future. Finally, youth programs through Playhouse Stage Company promote employment in the arts and culture sector, securing more reliable jobs for members of our creative economy in the form of teaching artists, musicians, technicians, and more. Employment in this sector of the work force has grown nationally by over 30% in the past 10 years, and PSC is proud to be a major contributor to this growth within the Capital Region.

Please describe your organization's ability to implement the project you propose including organizational structure, staff members involved, a summary of similar initiatives you have undertaken and the date they were completed:

Playhouse Stage Company launched a revamp of the youth program in the wake of the pandemic, branding Playhouse Stage Academy as the official home for youth services to the field, including year-round classes, masterclasses, youth productions, summer camps, and scholastic touring productions to serve local school districts. Overseen by a Director of Education, this program is designed to meet students at their level of interest and skill to promote growth and positive development. Classes are offered for children ages 4-18, and are broken out by both age and discipline with well qualified and certified teachers overseeing each program. Youth productions have received regional recognition for excellence in both performance from students and the technical work of designers and program directors from publications such as BroadwayWorld. This program is an expansion initiative to be able to continue this work in a meaningful way, and provide the level of proficiency and support that our community has come to expect from the Playhouse.

How will you track performance goals and define success? Include at least two key performance indicators and expected annual outcomes/impact?

An indicator of our program's success that is already being seen is the increased attendance and interest we are seeing in youth productions, auditions, summer camps, and class enrollment. With this, the Playhouse is pleased to have found incredible young talent in our region, and this outreach has only helped to promote our work further in the community. We receive support from local businesses to help maintain our programming, and the youth education component of our work is always of particular interest. We have been delighted to welcome new partnerships with businesses, schools, and community groups thanks to this program, and look forward to its continued growth. The tremendous increase in the number of tuition assistance requests received at the start of each youth program really speaks to the need in our community, and the important role that Playhouse Stage Company plays for local youths. We are proud to have seen many Playhouse Students go on to roles on Broadway, in TV and films, or forging their way through other successful careers because of the skills and confidence learned through this program. We look forward to having enough support to keep up with the demand for scholarships and financial aid so that we can continue to say that we have never turned a student away because they could not afford to participate in the arts.
