Albany County seeks to enter into a partnership with the City of Albany and the College of Saint Rose for the purchase and installation of a new turf sports field at Hoffman Park in Albany. The cost of the turf field would be evenly split between the County and the City, with each contributing an equal \$250,000 share. Through the partnership, Albany County would reserve the right to utilize this field for its own recreational programming.
