## AMENDING THE 2021 DEPARTMENT OF RESIDENTIAL HEALTH CARE FACILITIES BUDGET: SECURITY GUARDS

By Audit and Finance Committee:

WHEREAS, The Executive Director of the Albany County Department of Residential Health Care Facilities has requested authorization to amend the 2021 Department of Residential Health Care Facilities Budget by increasing a Security Guard line in the amount of \$31,643 and Overtime line in the amount of \$6,229, and removing two Security Guard PT lines, and

WHEREAS, The Executive Director has indicated that this change is necessary for security at the Shaker Place Rehabilitation and Nursing Center, now, therefore be it

RESOLVED, By the Albany County Legislature that the 2021 Department of Residential Health Care Facilities Budget is amended as follows:

Decrease Appropriation Account NH6020.1 by \$37,872 by decreasing the following Line Items:

Decrease and Delete Line Item NH6020 1 4416 002 Security Guard PT by \$18,936

Decrease and Delete Line Item NH6020 1 4416 004 Security Guard PT by \$18,936

Increase Appropriation Account NH6020.1 by \$37,872 by increasing the following Line Items:

Increase Line Item NH6020 1 4415 308 Security Guard by \$31,643 Increase Line Item NH6020 1 9900 Overtime by \$6,229
