## **Justification**: (state briefly why legislative action is requested)

As part of my ongoing efforts to make Albany County a leader in sustainability, I am requesting authorization to allow Siemens Industry Inc. to submit interconnection applications to National Grid for three potential solar sites: the radar tower property, Albany County DPW, and Cornell Cooperative Extension. Siemens was selected as the proposed engineer and developer after the New York Power Authority conducted a Request for Proposals on behalf of the County and they provided the most complete and cost-effective option. After evaluation or several sites, the abovementioned sites were determined to be the most cost-effective and technically feasible.

The interconnection applications do not bind the County to move forward with projects at these sites; however, due to the length of the interconnection process it is advantageous to apply as soon as possible. The interconnection application allows the utility to complete a study of its infrastructure to the give the project a point of connection to the grid, inform the engineer of any necessary infrastructure upgrades, and provide the associated cost estimates. The attached documents (Customer Letter of Authorization, Appendix H, and Appendix B) must be completed by the county as part of the Engineer's interconnection application.
