Please be advised that the Albany County Board of Elections is seeking approval for the acquisition of ballot printers to print Primary, General and Special Election Ballots as part of our in-house ballot production operation. We received a quote from Konica Minolta, listed as a National Cooperative Contract under Sourcewell, Contract #030321-KON, for \$153,672.93. The price includes three (3) high-speed printers: 2 Monochrome Printers and 1 Color Printer, along with periphery software and a service contract.

The printers will be replacing aging equipment, originally purchased in 2013. The in-house ballot production operation has saved the county over \$1 million in ballot printing costs. Due to these ongoing savings, the cost of the ballot printers will recoup in two election cycles. Funding for the printers was appropriated in the 2023 budget.




