Legislative Action is being requested to convey tax foreclosed properties located in the City of Albany for their appraised values, 295 Second Street Tax Map No. 65.56-2-55 for \$18,000.00, 330 Orange Street Tax Map No. 65.72-5-7 for \$21,000.00, 395 First Street tax Map No.65.55-6-55 for \$18,000.00 to Mr. James Scaringe, 41 James Drive, Albany NY 12211.

Mr. James Scaringe indicates in his submission that these properties are in very poor condition, which will require that he will first stabilize each one. Mr. Scaringe also states that his plans are to rehabilitate these buildings, to creating apartments for low-income and homeless individuals.
