## <u>Justification</u>: (state briefly why legislative action is requested)

Pursuant to RFB-2023-149 the Department of General Services requests Legislative approval of a contract with Nickerson NY, LLC as the lowest qualified bidder with a base bid of \$3,312,847.00 and a 10% contingency of \$331,284.70 for a not to exceed cost of \$3,644,131.70.

Under this contract Nickerson NY, LLC will remove existing upper level seating and provide and install new replacement seating of the MVP Arena.

This project is included in the Civic Center A Fund 2023-2027 Capital Plan and associated costs will be covered by bonds HKUJ Res. No. 553 of 2015 adopted December 14, 2015, HKUW Res. No. 502 of 2017 adopted December 4, 2017 and HKUZ Res. No. 517 of 2019 adopted November 12, 2019.

The Projected term of the contract is April 1, 2024 through March 31, 2026
