Thank you for discussing with me the "Omitted Sewer - '21" item for \$2,258.39 shown on the 2023 Town and County Property Tax Bills (please see attached) which my clients received earlier this month for the above referenced property (the "Property").

As we discussed, my client, J&J 19 Idlewild Park LLC, purchased the Property in March of 2022. At that time, we had contacted the Town to obtain water and sewer readings for the Property in order to pro-rate any amounts due from the seller at the closing. During those calls, we always request whether there are any past-due water or sewer bills. We were told during that call that there were no past due bills and we were provided with the most current water and sewer reading which was collected and/or credited at the closing.

Therefore, my client was extremely surprised to see the "Omitted Sewer -'21" item included on his most recent property tax bill. My client called the Town and was told that this figure represented sewer charges which the Town had inadvertently neglected to bill from a prior owner (despite the fact that the paid tax bills available online for the past few years all show sewer fees billed and paid in full; please see attached).

I also contacted the town and received the attached letter dated January 11, 2023 in response to my inquiries on this matter. That letter indicates that the Town mistakenly sent notice of the omitted sewer fees issue to the prior owner in September od 2022, despite the fact that my client had been the owner of the Property at that time and had been on the tax rolls as the new owner for approximately six months by the time such letter was issued.

Please see attached Form RP-554 requesting that the tax rolls be corrected to remove the Omitted Sewer — '21" amount of \$22,258.39 from the 2023 Town and County Property Tax Bill, so that my clients can pay their 2023 property taxes. The tax collector will not accept partial payment, so this request is urgent in that my client will need the revised tax bill without the "Omitted Sewer — '21" item included so that they can pay their tax bill before the end of the month.

If the revised tax roll and tax bill cannot be issued before the end of the month, please also accept this letter as a request to waive any late fees, interest and penalties that could result from a payment being submitted after January 31, 2023, as a result of the corrected tax bill being issued after that date

RE: Request for Revised Sewer Bill

Dear Ms. Borden,

We are in receipt of your message, dated January 10, 2023, and subsequent email correspondence, dated January 11, 2023, regarding the sewer charges for 19 Idlewild Park ("Property"). We have reviewed your request for a revised tax bill and write to inform you that we are unable to issue a revised bill.

By way of background, the sewer charge referenced in your communication is an adjustment of prior underbilled sewer rents. Although certain sewer rents for the Property were previously paid to the Town, the amount previously paid was less than actual sewer usage at the Property. Accordingly, the amount due for actual sewer usage at the Property was assessed against the Property as an adjustment to correct the amount previously underbilled. For your reference, a copy of the correspondence previously sent to the Property explaining the reason for this adjustment is attached hereto.

As you may know, the Town has a statutory obligation to annually report any unpaid taxes, including special assessments like this sewer charge, to Albany County ("County"). In accordance with such statutory obligation, the Town reported the amount owed to the County for inclusion on the January 2023 tax bill. Accordingly, this charge is now within the purview of the County and any request for recourse is more properly pursued through the Albany County Real Property Tax Service Agency.
