Justification: (state briefly why legislative action is requested)

The Public Defender and the Alternate Public Defender Office's request approval to accept an authorized, NYS Office of Indigent Legal Services (ILS) Third Counsel at First Appearance Grant (CAFA3) contract. Due to the delay in start of CAFA1 and subsequently CAFA2, the CAFA2 contract had to be extended until December 31, 2021, so that all the funds from CAFA2 contract could be utilized. Both Offices are requesting permission to continue the Counsel at First Appearance program, where attorneys from both the Public Defender's Office and the Alternate Public Defender's Office appear for every arraignment for every indigent individual who is arrested and charged with committing a crime within Albany County. CAFA is entirely funded by the State and provides both of the departments the resources to provide legal representation 24/7 for any indigent individuals arrested. CAFA 3 will continue to provide services that were previously provided by CAFA 1 and CAFA 2.
