## **Justification**: (state briefly why legislative action is requested)

As a Preferred Source Vendor under New York State Finance Law Section 162 New York State Industries for the Disabled, Inc. will provide daily janitorial and day porter services for the Family Court, Judicial Center and Stedman House. The Three (3) year term has a projected cost of \$1,167,730.00, further detailed in the cost tabulation sheet. This projected total assumes a prevailing wage increase of 10% beginning July 1<sup>st</sup> of each year. The agreement will commence on January 1, 2023 and run through December 31, 2025. At the end of this term, the Parties may, by mutual agreement, renew for (2) additional consecutive one-year terms, with the same service terms and pricing structure. Under the current OCA agreement the State will reimburse the County 79% of the actual cost for the Family Court and 53% of the actual cost for the Judicial Center.
