The Department for Aging is requesting legislative authorization to amend Resolution No.259, adopted 7/10/2023, approval for the following;

To accept the stimulus funding for III-C-2 Home Delivered Meals Program from New York State Office for Aging. This funding will provide additional needed home delivered meal services to older adults living in Albany County.

New York State Office for Aging has advised that there is a change in funding for Title III-C2 Congregate Meal Program from \$216,242.00 to \$311,162.11 and 10% County funded.
