The Albany County Water Purification District (District) is requesting authorization to enter into a contract with International Dioxcide Inc (IDI) for the supply of odor control oxidant per the above subject bid.

The contract term is for one year, scheduled to run from January 1, 2023 through December 31, 2023, with the option for two (2) one year renewals. The estimated contract amount for the one term is \$200,000 per year.
