<u>DESCRIPTION OF REQUEST:</u> (state briefly why legislative action is requested)

Pursuant to 18 NYCRR 352.8, Local Social Service Districts are required to provide emergency/transitional shelter to homeless individuals and families. Therefore, authorization is requested to renew an agreement with the Altamont Program to operate its Thornton Ave. Shelter to house up to ten (10) single women experiencing homelessness to help meet the community's need for emergency transitional shelter for women in Albany County.

Between January 1st through October 1st, 36 clients have been served at Thornton Ave Shelter.
