

I am in receipt of your recommendation to award the aforementioned Proposals to H2M Architects + Engineers.

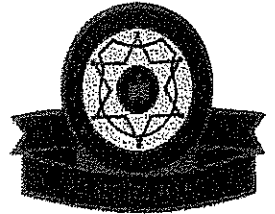

In regards to RPF # 2020-098 New Clarksville 911 / EOC project we have reviewed all the responses and recommend H2M Architects and Engineers be awarded the bid for the Clarksville 911-EOC project. H2M is the only firm of all the bidders that have completely designed and completed a combination 911 and Emergency Operation Center (EOC) facility in its entirety. H2M has designed, built and assessed over 300 emergency response facilities including 911 Public Safety Answering Points (PSAP), Emergency Operation Centers, Emergency Management and Public Safety facilities. H2M offers the most experienced design team, its top two team members, David J. Pacheco and Dennis A. Ross hold positions on the Department of Homeland Security's EOC Standards Committee and the National Fire Protection Agency's Health and Safety Committee respectively. As their proposed fee amount is not the lowest, we considered their expertise, their understanding of the project, and their experience with similar projects, makes them the most appropriate, combine that with their total price with the inclusions and exclusions it makes H2M the best choice to award this contract.
