EVIDENCE INGESTION

- Staff has multiple ways to upload digital evidence.
- Axon Community Request to allows you to send anyone a secure link via email or text to upload digital evidence. Allowing your staff to avoid driving to pick up files or sharing their email/mobile number. This evidence is scanned for viruses and can be automatically loaded to the case with a secure chain of custody.

RETENTION & SECURITY

You own your data and can set retention policies specifically for your office. Axon does NOT have access to your instance of evidence.com and cannot review/access your digital evidence. Unlimited secure cloud storage gives your office a centralized and secure location for all digital evidence. Unlimited cloud storage ends the days of hunting down critical emails, documents and files across USB drives, CDs/DVDs and hard drives because archiving digital evidence is not required.

- Store all digital evidence, regardless of file type, in one secure location. Axon utilizes Microsoft Government Cloud, housed entirely in the continental US. Replication for disaster recovery is also included.
- Cloud-based storage allows your attorneys to access digital evidence wherever their work takes them.





- Trace every piece of evidence to the accused, docket number, and other data sets through a detailed audit log.

DIGITAL EVIDENCE REVIEW with CMS INTEGRATION

Justice Premier was built from the ground up to empower you to review more evidence in less time. All new evidence uploaded will be marked "New" to the office and separately to the user. Confidently know the status of every piece of digital evidence at-a-glance - so nothing falls through the cracks.

AI Transcription

- Our constantly improving Transcription tool creates accurate video and audio transcription within minutes. Supported languages include English, French, and Spanish. Transcribe any file up to 16 hours in under 10 minutes.
- Transcripts are editable and time-synched to the video. Side-by-side transcript/video dramatically reduces review time.

3rd Party Video Playback

- Reviewing video evidence can be difficult because it is often sent to you
 in proprietary formats. This typically requires time to find the digital
 player and then install a custom player to view files. With Axon, we
 handle finding the custom player and allow users to simply press play
 without additional steps required.
- Upon ingest into your account, approximately 96% of proprietary video formats will be transcoded and viewable without the proprietary player.
- Extract files into an MP4 to download, share, redact, and transcribe these assets just as you would any MP4 video file.
- Multi-Cam Video Playback
- Multi-cam playback allows videos that were recorded by different cameras, but in the same location and time, to be found and viewed together. Axon then automatically time-synchs these video files so users can view up to four different angles at the same time.
- After the views are chosen and synched, users can extract a single file that contains all 4 views in one. This is extremely helpful for increasing situational awareness when presenting to the jury.





Redaction Assistant

With just a few clicks, automated redaction masks for faces, license plates, computer screens, and PDF's with the click of a button. Additional features include video editing features such as muting audio and highlighting videos.
