With the September deadline approaching and the funds not yet received, it will be very challenging to spend the amounts within that timeframe—particularly given county procurement processes, especially for items like computer equipment.

To ensure we can use the funds effectively, we would like to propose extending the timeline through the end of December for the following:

- Mobile Crisis: \$19,873.62
- Jail Diversion: \$15,914.78
- Peer Capacity: \$5,330.00
- **Total: \$41,118.40**
