DESCRIPTION OF REQUEST: (state briefly why legislative action is requested)

General Services is requesting a cost amendment to contract Res. No. 519 of 2022 Authorizing an Agreement with Bunkoff General Contractors, Inc. as the General Work Contractor (GWC) for the Capital District Juvenile Detention Facility.

Res. No. 519 of 2022 has a not to exceed cost of \$10,492,000.00 with the term ending December 31, 2025. The requested amendment will provide an additional \$319,961.00, bringing the not to exceed cost to \$10,811,961.00.

The Additional costs in part have been driven by additional work required at the facility due to existing conditions discovered in which added scope was required to meet code requirements and to address existing deficiencies identified. In addition, during turnover of various areas approving agencies (OCFS, SCOC, Sheriff's Dept. and DASNY) identified program and or security needs that warrant additional scope.

All terms and content of Res. No. 519 of 2022 will remain in effect.
