This suite holder (NYSCOPBA) was originally in Suite #19. Bank of America was in Suite # 12, but they elected not to renew their suite lease. NYSCOPBA was first on the list of suite holders that are located behind the stage to have the right to move to a better location if another suite opened up. Therefore, NYSCOPBA moved into Suite # 12 effective as of 9/1/2022. Saratoga Eagle entered into a lease that was authorized by the Albany County Legislature pursuant to Resolution # 400 and adopted by the Albany County Legislature on 11/14/2022.

The authorization to move NYSCOPBA to Suite #12 was accidentally not caught and this is to officially get the move authorized.
