## **Justification**: (state briefly why legislative action is requested)

The City of Albany Assessor, Mr. Trey Kingston, has submitted an Application for Refund or Credit of Real Property Taxes on behalf of Campus View II Apartment, LLC to correct an erroneous 2022 property tax bill issued for 841 Western Ave, Albany NY, tax ID number 64.6-2-1. An error of essential fact, as defined by RPTL §550 (3) (a), has occurred. Physical improvements to the real property were removed prior to taxable status date 2021. However, the assessment roll does not reflect the change in parcel inventory and taxes were levied against a structure that no longer existed.

Real Property Tax Law §550 (3) (a) allows for the correction of Errors in Essential Fact made on the assessment and tax roll. I recommend that the Albany County Legislature approve the correction to the tax rolls and authorize the refund of \$9,227.52.
