#### **Justification**: (state briefly why legislative action is requested)

Authorization is requested to renew agreements with two providers of home establishment furnishings. Local Social Services districts are required to provide for the purchase of necessary and essential furniture, furnishings, equipment and supplies required for the establishment of a home for persons in need of public assistance when provision of such cannot otherwise be made. The rule applies when an eligible household or member of such is relocating to permanent housing from an institution, residential program, or other temporary living situation or when an individual or family must be re-housed in unfurnished housing due to health and safety concerns involving their current accommodations.

Essential Household Item rates were established pursuant to part 352.7 of the Social Services Law and the regulations of the New York State Office Temporary Disabilities. Below are the negotiated rates established by Albany County:

#### **Essential Household Items**

Item Maximum Amount Allowable

Living Room \$325.00 Single Bed or Crib \$215.00 Two Single Beds \$279.00 Double Beds \$270.00

Kitchen \$260.00 (Plus \$12.00 for each additional person)

Range \$182.00

Refrigerator \$182.00 (or \$258.00 for four or more persons)

Authorized rates cannot exceed but may be less than those in the above schedule.
