Justification: (state briefly why legislative action is requested)

The Department of Public Works is requesting the Legislature's approval of the attached Supplemental Agreement between Albany County and the NYS Department of Transportation (NYS DOT) regarding construction and design services for CR9 (Bradt Hollow Rd.) over the Fox Creek Bridge Reconstruction Project.

The original CR9 over Fox Creek bridge replacement project was 80% federally funded. Upon construction completion of the bridge, it became apparent that additional work was required to correct a settlement issue on the bridge approach. This supplemental agreement allows the County to receive 80% federal reimbursement for the additional construction costs incurred to correct the approach settlement issue. The cost of the additional work was \$1,099,712.74, thus this agreement allows the County to be reimbursed \$879,770.19.

Albany County is administering this federal-aid project. Because of this, Albany County paid 100% of the design and construction (for both the original bridge replacement and the additional settlement correction work), and will receive 80% Federal Reimbursement. The funding for our share of this project was authorized by the Legislature in Bond Resolution No. 175 dated 5/8/2017 and Resolution 356 dated 8/13/2018 (attached).
