The attached correspondence is forwarded for presentation to the Albany County Legislature.

Legislative approval is required in order to allow the Albany County Sheriff's Office to enter into a grant contract wherein the original grant end date is being extended with the State of New York, Division of Homeland Security and Emergency Services, for the 2022 Domestic Terrorism Prevention Grant. Approval is also sought to authorize the Sheriff's Office to move \$11,540.00 from budget line A93110.4.4046DTP22 to A93110.1.9900DTP22. These actions will enable the most efficient use of the grant funding as the needs of the Threat Assessment Management Team evolve in response to ongoing public safety needs.

The performance period for this grant is being changed from September 1, 2022 through August 31, 2024 to September 1, 2022 through August 31, 2025. This grant was previously authorized under resolution 22-377, attached hereto.

Awarded funds remain at \$172,413.00 with no match. This grant funding is being utilized to create and administer a multidisciplinary Threat Assessment Management Team as previously authorized.

WHEREAS, The Albany County Sheriff has requested authorization to submit a grant application to and enter into an agreement with the New York State Division of Homeland Security and Emergency Services for the FY 2022 Domestic Terrorism Prevention Grant in an amount of \$172,413 for a term commencing September 1, 2022 and ending August 31, 2024, and

WHEREAS, The Sheriff has indicated that the aforementioned grant funds will be utilized to create a multidisciplinary Threat Assessment Management Team, and

WHEREAS, The Sheriff has also requested a budget amendment to incorporate the aforementioned grant funding into the 2022 Sheriff's Office Budget, now, therefore, be it

RESOLVED, By the Albany County Legislature that the County Executive is authorized to submit a grant application to and enter into an agreement with the New York State Division of Homeland Security and Emergency Services for the FY 2022 Domestic Terrorism Prevention Grant in an amount of \$172,418 for a term commencing September 1, 2022 and ending August 31, 2024, and, be it further

RESOLVED, That the 2022 Sheriff's Office Budget is hereby amended as follows:

Increase Revenue Account A3306 Homeland Security by \$172,413

Increase Appropriation Account A3110.1 by \$99,000 by increasing Line Item A3110 1 9900 Overtime by \$99,000

Increase Appropriation Account A3110.4 by \$73,413 by increasing Line Item A3110 4 4046 Fees for Services by \$73,413
