## **Justification**: (state briefly why legislative action is requested)

The Department of Mental Health requests permission to enter into a contract in 2024 with Homeless and Travelers Aid Society (HATAS) for the provision of supported housing, transportation and outreach services to Albany County citizens suffering from mental illness. NYS Office of Mental Health (OMH) will provide pass through funding to HATAS through Albany County Department of Mental Health for \$745,154. This appropriation is anticipated in the 2024 budget. There is no County share associated with this contract
