As part of the Albany County 2024 - 2028 Capital plan, the Shaker Place Garage and Parking Lot Extension project was created to construct a multi-use facility for vehicles of Shaker Place to be stored and maintained along with providing the Albany County Department of Public Works (DPW) with modern facilities at their Colonie site. AOW Construction is the lowest responsible bidder for the general construction of the facility.
