Through its attorneys, Overton, Russell, Doerr and Donovan, LLP Attorneys and Counselors At Law, Trustco Bank has exercised its fourth 10-year option to renew the existing lease. The term of this renewal is April 1, 2022 through March 31, 2032.

Trustco Bank has also requested that the existing lease be further modified to provide for four additional 5 year options to renew. Rent for the first two 5 year options would remain at the current rate with the remaining option terms to be negotiated by and between the parties subject to paragraph 41 of the lease.

Except as further modified and extended by the proposed Agreement, the terms and conditions of said Lease as heretofore, assigned and renewed would remain in full force and effect during the fourth renewal term thereof.
