Justification: (state briefly why legislative action is requested)

The Albany County Department of Public Works is requesting authorization to apply for BRIDGE NY funding. Bridges include County Route 53 over the Onesquethaw Creek in the Town of Bethlehem, County Route 111 over the Spillway in the Town of Coeymans and County Route 111 over the Hannacrois Creek in the Town of Coeymans. The culvert is located on County Route 301 in the Town of New Scotland. BRIDGE NY funding would provide 95% of the originally authorized project costs for bridges and 100% of the originally authorized costs for culverts. The Governor's 5-year Capital Program continues the BRIDGE NY Program at a funding level of \$200M per year. The Bridges are eligible for \$500,000-\$5,000,000 in funding and culverts are eligible for \$100,000 to \$1,500,000.
