RESOLUTION NO. 189

AMENDING THE 2021 SHERIFF'S OFFICE BUDGET: VEHICLE MAINTENANCE

Introduced: 6/14/21

By Audit and Finance Committee:

WHEREAS, The Albany County Sheriff has indicated that it is necessary to amend the 2021 Sheriff's Office Budget to allow for the payment of costs related to the re-chassis of a County ambulance, and

WHEREAS, The Sheriff has requested authorization to amend the 2021 Sheriff's Office Budget to provide for the aforementioned payment, now, therefore, be it

RESOLVED, By the Albany County Legislature that the 2021 Sheriff's Office Budget is hereby amended as follows:

Decrease Reserve Account A00890 Reserve EMS Ambulance Fund by \$118,000

Increase Appropriation Account A3110.2 by \$118,000 by increasing Line Item A3110 2 2400 Automobiles by \$118,000

and, be it further

RESOLVED, That the Clerk of the County Legislature is directed to forward certified copies of this resolution to the appropriate County Officials.
