DESCRIPTION OF REQUEST: (state briefly why legislative action is requested)

General Services is requesting authorization for a contract with Spring Electric, Inc for MVP Arena Power Upgrades and Transformer Replacement. The purpose of these upgrades is to provide adequate electrical supply for arena events.

Of the ten bids received for RFB#2024-137 MVP Arena Show Power and Transformer Replacement, Spring Electric, Inc. was the low bidder and has met all RFB requirements. The not to exceed cost of \$468,600.00 includes the base bid of \$426,000.00 plus a contingency allowance of \$42,600.00. Costs for this project will be covered under Bond HKUW Res. No. 502 of 2017 dated December 4, 2017.

The anticipated term of the contract is February 1, 2025 through January 31, 2026.

This proposed project meets the criteria established for SEQR Type II actions pursuant to 6 NYCRR 617.5(c) subdivision (1)(31). Accordingly, this action has been determined not to have a significant impact on the environment, and as such, no procedural compliance with SEQR beyond this determination is required at this time.
