## **DESCRIPTION OF REQUEST:** (state briefly why legislative action is requested)

Request for approval of contract renewal - Atalian Global Services US which has since been acquired by GDI Services, Inc effective as of November 1, 2023. The current cleaning contract for the arena, parking garage and walkway is scheduled to expire on September 30, 2025 (the initial term). Within the current contract there is a mutual option to renew the agreement for one (1) additional three-year term.

GDI has done an excellent job cleaning the facility, garage and walkway. We are asking for approval to exercise the mutual option to enter a second term for three additional years, which will extend from October 1 2025, through September 30, 2028. GDI is subject to and is required to pay prevailing wages to its staff members.
