The Department of Mental Health requests permission to enter into a contract in 2023 with Unity House of Troy (formally Northeast Career Planning-The Workshop) for the provision of supported education, transformed business model, PROS and sheltered workshop services to Albany County citizens suffering from mental illness. NYS Office of Mental Health (OMH) will provide pass through funding to Unity House of Troy through Albany County Department of Mental Health in the amount of \$375,909. This appropriation is anticipated in the 2023 budget. There is no County share associated with this contract.
