The Albany County Public Defender's Office, Alternate Public Defender's Office, and Assigned Counsel Program are requesting authorization for an agreement to amend the Distribution #14 grant with the NYS Office of Indigent Legal Services. The amendment incorporates funding to continue the initiatives currently funded in Distributions #12 and #13, increasing the total to \$2,360,184.00. All revenue is anticipated in the County's proposed 2025 executive budget.
