The Department of General Services, in partnership with the Office of the County Executive, requests funding authorization in the amount of \$1,000,000 for Green Capital Projects in the County. The purpose of this project is to accelerate the decarburization of County operations through capital investment including, but not limited to, zero and low emissions vehicles and infrastructure, renewable energy technology, clean heating and cooling, energy efficiency improvements, and green infrastructure projects.

The project has been included in the 2023 Capital Plan.
