## **DESCRIPTION OF REQUEST:** (state briefly why legislative action is requested)

The three-year time limit to use the ordinary correction of errors process has expired, therefore, enclosed for your review is a resolution. Upon review of the List of Delinquent Taxes, it became apparent that tax bills were imposed on properties owned by New York State. Property owned by the State of New York are statutorily real property tax exempt pursuant to RPTL §404.

I am requesting that he Albany County Legislature adopt a resolution canceling the unenforceable tax liens. Additionally, I am requesting that said resolution authorize the chargeback of all amounts credited and guaranteed by the tax liens.

In total 136 tax bills were identified as having been levied against property owned by the State of New York. These bills were issued between 1995 and 2023. The total amount of the unenforceable tax is \$209,237.20.
