#### **DESCRIPTION OF REQUEST:** (state briefly why legislative action is requested)

The Albany County Real Property Tax Service Agency is requesting authorization to release a right of reverter of title to 26 Trinity Place, City of Albany, Tax Map Identification Number 76.49-4-41. 26 Trinity Place was conveyed to the Capitol Hill Improvement Corporation with deed Liber 2380 Page 1156 in December 1998. Deed Liber 2380 Page 1156 contained a right of revert which would return title to Albany County if the Capitol Hill Improvement Corporation failed to meet the conditions outline in said deed.

All conditions for the release of the reverter have been meet by the Capitol Hill Improvement Corporation. The Real Property Tax Service Agency is requesting that the Albany County Legislature issue a certificate of compliance and release of reverter which indicates that the satisfactory rehabilitation of 26 Trinity Place has occurred.
